### 1. Content of Programme

The Caribbean Child Development Centre (CCDC) was established in 1973 with funding from UNICEF as a regional centre for research and training in early childhood education and care. A specialized unit of the then University of the West Indies Extra-Mural Department, the CCDC has undergone various organizational changes, and since 2008 has been a part of the Consortium for Social Development and Research, a division of the University of the West Indies, Open Campus. Over the years, the range of activities has varied while maintaining a focus on issues of child development covering the birth to 18 years age group. Over the past 4 years, issues of children's rights have also been an important aspect of the Centre's work. During 2011 the areas of focus were:

- 1. Research
- 2. Teaching/training
- 3. Networking and information dissemination
- 4. Public service

Our *research* efforts concentrated on Childhood Development and HIV. The year was spent completing papers from concluded projects and writing proposals for new research initiatives. Details are presented in section 5: '*Development of New and Ongoing Projects*'.

Our *teaching/training* programme included Child Rights and Responsibilities training and post-graduate supervision, as well as specialized training sessions which form part of our outreach programme. Work continued on the use of internet-based technologies for teaching and training as well as for general communication. Details of the work carried out are presented below in section 5.

Our *networking* activities included hosting multiple websites, managing various information databases, and the use of satellite technology to host teleconferences across the Caribbean. The Centre continued to be represented on several national, regional and international groups; this has facilitated linkages, and increased communication and collaboration among individuals and organizations.

**Public service** is encouraged among all members of staff, and CCDC is represented on multiple boards and committees.

### 3. Problems encountered and attempts to solve them

The CCDC continues to be challenged in sourcing funding for its programme of activities. All projects are funded by local and or International Development Partners hence proposal writing consumes a large portion of staff time. The University of the West Indies Open Campus covered most staff and operating cost in 2011, however the Centre was forced to curtail its operating expenses as the budget was affected by cash flow challenges. The Government of Jamaica through the Early Childhood Commission continued to provide a small subvention towards support staff cost for the years 2010-11and 2011-12.

The Centre continues to generate a portion of its own resources through rental/lease of sections of the premises to a day care/early childhood institution ("Kids on Campus"). This allowed us to undertake staff welfare/recognition activities.

The building continues to age and we have had to carry out increasing repairs to fixtures and plumbing. Most areas are in need of painting however this was postponed due to budgetary constraints. Plans are in place to carry out painting in phases and utilizing staff to reduce the labour cost associated with external contractors. The roof over the kitchen, library and day care developed cracks; estimate of repairs are being sought.

The Mona Maintenance Department has been slow to respond to needed retrenching to avert the flooding which occurred in 2010 however lobbying efforts continue to have this done. We had anticipated that work would also have been carried out to connect the Centre's sewerage system to the central sewerage network; this remains pending due to the scarcity of funds.

### 5. Developments with new and ongoing projects/ programmes

During the reporting period, the Head of the CCDC, Professor Julie Meeks Gardner, proceeded on one year Sabbatical leave effective August 1, 2011. The Acting Head, Ceceile Minott continued with the existing programme of activities as well as spear-headed the centre's early childhood training initiative.

### 5.1 Research

### 5.1.1 Research Theme: Aggression and Violence among Children

a) Involvement in gangs and related socio-emotional and cognitive development.
 Data have been collected to more clearly describe youth involved in gangs across
 Jamaica, including both boys and girls, as part of the study on the effect of individual level interventions on youth crime and violence. Analysis is ongoing.

### 5.1.2 Research Theme: HIV and Child Development

- a) HIV Stigma and Discrimination Among School Children in St. Lucia and Guyana This UNESCO-supported project which described the experiences and perceptions of children who were either HIV positive, or were affected by HIV through having an infected family member was completed early 2011. A research paper has been written and awaiting publication. A proposal has been prepared to replicate the study in Jamaica and compare the findings across the three Caribbean countries.
- b) Sexuality Education in the Caribbean

  This project comprises a situation analysis of the legislation, policies, programmes and curricula related to sexuality education in 9 Caribbean countries, and experiences of educators and learners. The project, commissioned by UNICEF and led by UWI Consulting, was completed in 2011 and the findings presented at the Regional Consultation on Teacher Preparation Sexuality Education, CARICOM Working Group on Health and Family Life Education meeting in St. Lucia, April 11- 12, 2011.
- c) Interventions to promote the development of children affected by HIV

  A research study to develop and pilot interventions to improve the development of children living with HIV was written and awaiting funding.

### 5.1.3 Research Theme: Early Childhood Training

a) Early childhood education, care and development (ECECD) programmes and courses offered throughout the English-speaking Caribbean were identified and a registry created to provide information to prospective students. Gaps were observed such as difficulties in moving from a certificate to a bachelors' degree when no bachelors' programmes were offered in that country. This created the opportunity to expand the levels and types of early childhood programmes offered in the Caribbean. The findings from this study was provided the background for the development of a Bachelors of Education in Early Childhood Development and Family Studies.

### **5.1.4** Research Theme: International Child Development

a) The Global Child Development Group

The CCDC has hosted the secretariat of the Global Child Development Group (GCDG) since its inception, and assisted with two international meetings which were convened in Jamaica for the development of a second series of papers on Child Development. The secretariat has been supported by the Bernard van Leer Foundation, GAIN and UNICEF. This small group, includes CCDC's Julie Meeks. The second series was published in the Lancet and was launched in Washington in September 2011.

### b) Childwatch International Research Network.

The CCDC has been a Key Institution of this international network since 1990. The CWI comprises research centres from over 40 countries. CCDC remains active in the regional network of the Caribbean and Latin America.

### 5.2 Teaching/Training

5.2.1 Continuing from 2010 UNICEF Jamaica supported a 40 hour face to face training of trainers' course on Child Rights and Responsibilities in 2011. The course was offered to 18 members of the Ministry of Education (Jamaica) Guidance and Counselling Department however only 13 persons completed the course. Under UNICEF's Child Rights Sustainability Initiative, support was forthcoming for the institutionalization of child rights training and child rights practices within the Department of Correctional Services (DCS).

At the end of the project, which commenced in November 2011, it expected that 10 DCS staff will be trained as Master Trainers; 150 recruits at the Carl Rattray Staff College will be equipped with child rights knowledge and tools; 220 members of the Metcalfe Street Remand Centre for juveniles will be equipped with child rights knowledge and tools to apply a rights-based approach to their duties; 208 boys at Metcalfe Street Remand Centre will be sensitized to the CRC, its application in Jamaica and relevance to them; and Child Rights training will be infused into the programme for Correctional and Probation Officers at the Carl Rattray Staff College.

5.2.2 The staff of the CCDC continued supervision of UWI graduate students in the MA of Communication for Social & Behaviour Change, and undergraduate students pursuing the BSc in Psychology.

5.2.3 Two one-day workshops on Child Rights and Research Methods were jointly hosted by CCDC and SALISES for 103 students and teachers from 47 urban and rural secondary schools, and 226 students and teachers from 67 urban and rural primary school. The workshops were carried out in April and May 2011.

### 5.3 Networking and Information Dissemination

### 5.3.1 Caribbean Child Research Conference

The CCDC has partnered with the Sir Arthur Lewis Institute of Social and Economic Studies (UWI) and UNICEF, and other agencies to host the 6<sup>th</sup> Annual Caribbean Child Research Conference from October 19 to 20, 2011. There were 40 presentations representing research across a range of disciplines, as well as 10 student presentations. Over 800 participants attended the two day event.

5.3.2 CCDC collaborated with other units of the UWI Open Campus to participate in the 2011 Research Days hosted by the Mona Campus on January 27 and 28, 2011.

### 5.3.3 Websites

The CCDC through the kind support of UNESCO updated and re-launched the CaribECD website: (<a href="http://www.open.uwi.edu/caribecd/welcome">http://www.open.uwi.edu/caribecd/welcome</a>). The CCDC website (<a href="http://www.open.uwi.edu/ccdc/welcome">http://www.open.uwi.edu/ccdc/welcome</a>) is maintained by the Librarian and provides information on the Centre's activities, along with serving as a portal for the databases we have created for documents and programmes.

### 5.3.4 Electronic Forums, E-Newletter and Teleconferences

UNESCO provided support to CCDC to embark on a project to strengthen Caribbean Early Childhood Development through information sharing and discussion forums. An electronic forum was established on the CaribECD Website to facilitate discussion on various topics relating to early childhood development. The forums preceded four teleconferences held with regional colleagues in 13 countries with up to 105 persons in attendance. The project culminated with the dissemination of an electronic newsletter "CaribECD Link."
